The Sidney Center project is 100% funded by Amphenol unless there is left over EDA money to apply to the project. Received a grant agreement for the EDAP program which is the money we were counting on to pay off our line of credit. The IDA received approval from the state for the \$750,000 grant for distribution lines into the existing and new facilities for Amphenol.

Qualfon: Glenn Nealis updated the board. They decided to go to Texas. They are still interested in doing a project in Hancock in 2014. Glenn is going to be meeting with the principals from Qualfon to put together a new list of potential locations in Delaware County.

Margaretville Lodging LLC Update – Peter has to go through the SEQR process again. Glenn commented that he would like to wait until he has some financing in place. He does not have a contract from the state yet.
